- Amendment facility for Bill of entry and DTA Sales modules has been introduced. Now
 any request for changes in these modules can be made and processed ONLINE through
 this facility.
- Facility to Provisionally Assess Bill of Entries has been introduced.
- Turnaround Time Report (TAT) for Bill of Entry module is now available to DC's Office. This
 will facilitate DC office to review the time taken to process requests. The TAT report will
 provide details of all transactions which have been initiated but not closed.
- Reports for MOC: To facilitate accurate and fast availability of reports to MOC for monitoring the performance of Zones a facility has now been introduced in SEZ Online System which enables the Units and DC Office to prepare and submit the reports to MOC online through SEZ Online system.

Item upload facility: If there are many items in an invoice, it may be a time consuming exercise for the user to enter the details of each and every item using the screens of SEZ Online system. A simple facility has been provided to import an excel sheet (excel template available on our website https://www.sezonline-ndml.com under Download section tab) containing the item details of an Invoice directly into SEZ online system so that if data is already available in electronic format, it can be re-used and manual entry of the item details can be avoided.

Actions Required?

Payment through NEFT (National Electronic Funds Transfer): To facilitate an efficient, secure, economical and expeditious system of funds transfer and clearance, NEFT facility has been introduced. It is observed that many times, unit needs quick credit to their account for filling their transaction. In case of payment done via NEFT mode, NDML account gets credit on immediate basis. The payment is made on the basis of the account number and the name of the beneficiary customer, after due verification thereof. So for quick processing of payment & getting immediate credit in SEZ Online system, you are requested to make payment through NEFT.
