

# Do You Know?

**Free Form Request** – SEZ Online system has a facility i.e. Free Form Requests which can be used by the SEZ Units/Developers/Co-Developers to interact with the Office of Development Commissioner for various kinds of applications / permissions which do not have any specific notified format.

Instead of submitting the application physically, it may be submitted through SOS in electronic form. This helps the User to eliminate physical papers and the records of approval can be maintained safely in the system for future reference.

User has been provided with two options of Admin & Customs transactions for Free Form request. This feature can be currently used for requesting "Cancellation" or "Amendment" of a Custom transaction or for Administrative transactions.

# **Actions Required?**

**Completion of all transactions:** It is observed that many cases of Bill of Entry are pending for recording details of "Rewarehousing Completion". Please note that as per SEZ Rules it is required to certify "Rewarehousing Completion". All such entries where "Rewarehousing Completion" has not been marked will remain open in your inbox therefore please complete your requests.

Similarly in case of Shipping Bills please provide the final shipment status and EGM details for closure of the transactions.

Selection of correct system options: It is observed that many of the units, who intend to pay the Annual Fee, do not select the check-box "AMC Payment" but enter the AMC amount as a Account Deposit (Top-Up) against transaction fee. This leads to delay in updating the AMC Validity payment. Please select the check-box "AMC Payment" for AMC payment and system will show the amount due automatically. If it is intended to pay AMC as well as make an Account Deposit (Top-Up) payment; please enter the amount to be deposited in the Top Up field and also select the check-box for "AMC Payment" and system will display the total amount to be paid. This will help the system in recording your renewed AMC validity period expeditiously
